Foreign Distributor Application Requirements

Dear Prospective Distributor:

We have received notification of your interest in being a Distributor for our products. The distributorship requires the following:

- 1) Accepting the Advertising Policies set forth in Part IV of the Distributorship forms, signing it and returning it to our offices (info@envirohealthproducts.com)
 - a) We do not give permission to use either magneticclay or envirohealthproducts as part of your domain name.
 - b) Do not change anything in any published article by Lau'ana Lei and always reference the author when using any of her material.
SEE PART IV for specific and more detailed advertising information.
- 2) Sending a copy of a business license and/or resale tax permit required by your country to do business or sell a product.
- 3) Ordering a minimum of \$882.00 per order every 6 months in products.
- 4) No tampering with our products or adding to the kits any personal product info, including re-labeling without specific agreements with our Administration offices and signed by the CEO of our company or the manufacturer.
 - a) Keep all products stored in a moderate temperature and dry place.
 - b) Agree not to send out any damaged products or packaging.
 - c) Fill orders in a timely fashion (within 48 hours).
 - d) Provide customer service for clients.
 - e) Never prescribe to anyone unless you are an MD. Always focus on metal and chemical detoxing and NOT answering any questions directly related to diseases!
